Declaration of Informed Consent to Treatment

This is to acknowledge that I, _____ (patient name) as a patient of Dr. Ellen Wong, ND, have been informed and understand that:

- I am at liberty to seek or continue medical care from a physician or surgeon or other health care provider qualified to practice in Ontario;
- The treatment and therapies rendered or recommended by Dr. Ellen Wong may be different from and are not mutually exclusive of those offered by a medical doctor or licensed health care provider;
- I am not an agent of any private, local, county, provincial or federal agency attempting to gather information without so stating;
- However rare, there remain some risks to Naturopathic Medicine. These include, but are not limited to: aggravation of pre-existing symptoms, reaction to supplements or herbs, pain/fainting/bruising or injury from venipuncture (blood draw for lab purposes) and acupuncture, muscle sprains/strains, disc injuries from spinal manipulation;
- Dr. Ellen Wong will endeavour to provide the best possible diagnosis and course of treatment, but no guarantee has been made with respect to any treatment, action, or medical advice given, because many factors are important in determining actual results;
